Similar views were expressed by other Senate Members Dr.Savita Kansal, AP (CSE), Dr.A.S.Arora, AP (EIE), Dr. Sukhwinder Singh, HOD (CSE), Dr.P.K.Jain, HOD (EDP). Dr. Raj Rani Bhargava, Professor, IIT, Roorkee also expressed her dismay over non-implementation of decision of last Senate held. Dr.V.K.Jain, Dean (P&D) informed that during the last Senate Meeting, it was decided that Ph.D related programmes should be monitored and administrated by Dean (PG) since the Ph.D programmes comes under PG programmes. Dean (R&D) expressed that, it is related to administrative angle of the Institute and hence, it is decided to put up before the Director for his decision.
