- (i) The SLIET will not start / provide informal education without obtaining necessary approval of the Statutory Professional Regulatory Councils as is relevant, such as UGC, All India Council for Technical Education (AICTE), etc.
- (ii) The SLIET shall not open any off campus center or Centre of Excellence without obtaining the requisite prior approval of the UGC.
- (iii) The SLIET will continue to abide by the norms and guidelines laid down by the UGC, AICTE, etc. and the instructions issued by these agencies from time to time pertaining to the institutions notified as Deemed-to-be-Universities.
- (iv) The SLIET shall award degrees, etc in respect of the courses run by the Institute only to those students who are enrolled with the institute subsequent to the date on which this Notification takes effect for the purpose of the UGC Act, 1956.
- (v) As for the students who are already enrolled with the SLIET prior to the date of this Notification, they shall continue to been rolled with the present affiliating university, namely, the Punjab Technical University, Jalandhar, which shall examine and award degrees to them on successful completion of the courses / programmes they are pursuing at SLIET presently.
- (vi) The Institute shall not offer/award any degrees that are not specified by the UGC. The Institute will continue to ensure that the nomenclature of the degrees awarded by it are specified by the UGC under Section 22 of the UGC Act, 1956.
- (vii) The Institute will follow and adhere to the norms and guidelines prescribed by the relevant Statutory Professional Regulatory Councils before starting any new courses/programmes.
- (viii) As and when necessary, the Institute shall suitably amend and update its Memorandum of Association and Rules in consultation and concurrence with the UGC.
