REGISTRATION NOTICE

All the student want to register for the coming semester are advised to check the eligibility criteria as mentioned below, before filling the semester fee (i. e due from June 03, 2016 to July 21, 2016):

From I year to II Year: To be able to register in the Second year odd semester, a student should have completed, with D or better grade, at least 25 credits at the end of first year(in odd and even semesters and make up examinations put together). The students getting admissions through lateral entry will be automatically registered to the odd semester, second year at the time

From II Year to III Year : For promotion to Third year, a student should have (i) Cleared all the courses work requirements of 1 year (only for JEE entrant students) and (ii) passed, with D or better Grade, at least 25 credits in II year odd, even semester and make up examinations put together.

A student is required to earn minimum of 25 credits from the courses offered from the first and second semesters for registration in second year and third and fourth semester for registration in third year respectively. In case he/she fails to fulfill this condition, he/she shall be required to repeat the course(s), in which he/she failed to earn the pass grade, along with he/her junior batch as and when offered.

From I Year: To be able to register in the second year (III Semester), a student should have acquired CGPA equal to or greater than 3.5 at the end of second semester (In 1st and second semester and make up examination put together).

From II Year to III Year: To register in the third year, a student should have earned at least 60 credits in 1st and 2nd years and must have acquired minimum CGPA of 4.5 out of earned credits.

A student will be automatically registered to the first semester at the time of admission. In order to continue studies in 2nd, 3rd, and 4th semesters, the student must have regularly attended the 1st, 2nd and 3rd semesters respectively

Only those students will be permitted to register, who fulfils the above criteria and have:

- Cleared all the Institutes dues and hostel dues of the previous semesters. (i)
- Paid all the required fee for the current semester, and (ii)

Not been debarred form registering for a specified period on disciplinary or any other grounds.

The registration will be complete, only when, the students fulfill the eligibility criteria along with registration requirement as mentioned above, and get registered in-person with the concerned class counselor on July, 21, 2016.

Failing to fulfill any of the above, the registration will stand cancelled. The student may note it clearly that merely deposition of fee is not registration, It is mandatory to register in person with the class ue as per rules.
