NOTICE

The institute is going to offer Minor Degree w. e. f. Even Semester of Academic Session 2022-23. The Registration process for Regular Degree as well as for Minor Degree shall commence from 26th December, 2022 through ERP.

The Minor Degrees as per following nomenclature are being offered:-

1. Bachelor of Engineering (Minor) Computer Science & Engineering
2. Bachelor of Engineering (Minor) Chemical Engineering
3. Bachelor of Engineering (Minor) Food Technology
4. Bachelor of Engineering (Minor) Electrical Engineering
5. Bachelor of Engineering (Minor) Instrumentation & Control Engineering
6. Bachelor of Engineering (Minor) Electronics & communication Engineering
7. Bachelor of Engineering (Minor) Mechanical Engineering
8. Bachelor of Engineering (Minor) Management
9. Bachelor of Engineering (Minor) Computational Techniques (Mathematics)

The rules for registration of Minor Degree are as under:-

Eligibility:-

1. Minor Degree shall be offered to UG students starting from 4th semester onwards. Minor Degree shall be offered to the UG students from 2021 batch onwards.
2. There shall be a requirement of a minimum 08 students who shall be offered Minor Degree, in each department. However, the maximum/upper limit shall be 120 student plus 10%.
3. If more than 120 numbers of students opted for minor degree then, the merit of 3rd semester only shall be considered to select 120 students.
4. No credits shall be allowed to be transferred for the degree offered by departments.

Fee for Minor Degree: - The students will be allowed to register to earn additional 20 credits with reference to earning of 160 credits for Bachelor of engineering degree for the award of Minor Degree as per the study scheme of UG programmes. An additional fee of Rs. 5000/- (Rupees Five Thousand) per subject per semester during 4th, 5th, 6th, 7th and 8th semester will be applicable.

Note 1:- The student can opt for either Honors Degree or Minor Degree besides his/her regular degree. While opting for Minor Degree from above disciplines, it is to be ascertained that a student of any department cannot opt for Minor Degree offered by his/her own department.

Note 2:- The derailed rules for Minor degree are available on Institute Website in under Graduate Rules July 2022 onwards, under section C: UG M1 to UG M11, from page no. 32-34.

Note 3:- The students have to select the subjects of Minor Degree first during registration of regular semester subjects, and then the list of students finally selected for Minor Degree shall be notified in accordance with eligibility rules. After that, the selected students shall have to deposit fee for Minor Degree.
